

PRIVACY NOTICE ON THE PROCESSING OF PERSONAL DATA OF SOCIAL PROJECT BENEFICIARIES

This privacy notice was drafted by **Stichting United Work Turkey Representation (“SUW”)** as data controller in accordance with Article 10 of the Turkish Law No. 6698 on the Protection of Personal Data (“**Law**”) and the Communiqué on the Procedures and Principles of Fulfilling the Obligation to Inform.

For the purposes of (a) providing you with appropriate level of support to meet your specific needs, (b) ensuring that social aid projects can be performed in line with their purposes, (c) raising awareness about current living conditions in the area where you live; your personal data (name-surname, date of birth, age, nationality, gender, education, health information, personal history, financial status and ID/passport number, address of residence) – that you share under your social aid application form that you fill in within the scope of social aid projects - will be processed by SUW through automatic and/or non-automatic means and transferred to suppliers and authorized public institutions and organizations based on the legal grounds provided under Article 5/2 of the Law, which states that *“the processing activity is necessary for the realization of legitimate interests of the data controller [and] the processing is mandatory for the data controller to be able to perform legal obligations”*; also your personal data will be transferred to SUW’s suppliers and donors as well as relevant local municipalities and authorized public institutions and organizations for the realization of the above-mentioned purposes, and will be transferred abroad for the purpose of performing the services that SUW will provide to you.

Within the scope of the law, nationality, gender, health information constitute “sensitive personal data”. These data will be processed by SUW based on your explicit consent for the purposes stated above and will be transferred to the above-mentioned third parties and abroad.

You may submit your requests to SUW (info@unitedwork.org) in accordance with Article 11 of the Law concerning “the rights of the data subject” in accordance with the Communiqué on the Procedures and Principles of Application to a Data Controller.

EXPLICIT CONSENT REGARDING PROCESSING AND TRANSFER OF PERSONAL DATA ABROAD

I acknowledge that I have read in whole and understood “**PRIVACY NOTICE ON THE PROCESSING OF PERSONAL DATA OF SOCIAL BENEFICIARIES**” and that I was adequately informed by SUW on the processing and transfer domestically and abroad of my personal data in the scope of the Law.

I acknowledge that with my hereby explicit consent expressed through circling or crossing options below, I am allowing my personal data to be stored, processed and transferred to above-mentioned third parties domestically and abroad and limited to the purposes which are stated and for the maximum period necessary for the purposes or statutory limitation periods and I declare that I was informed by SUW in a way that does not give rise to any hesitation in this matter and that I have expressed my explicit consent in accordance with the Law.

Regarding my own personal data:
